ALL PRODUCT MUST BE MADE WITH CALIFORNIA COMPLIANT (CAC) PASTEURIZED FROZEN WHOLE EGGS, STEAM COOKED AND IQF FROZEN INTO PRE-COOKED PRODUCT TO MEET USDA FNS INSTRUCTIONS 219. EACH SERVING BY WEIGHT OF PREPARED PRODUCTS TO PROVIDE 1.0 OZ. MEAT/MEAT ALTERNATE FOR THE CHILD NUTRITION MEAL PATTERN REQUIREMENT AND PACKED SO THAT INDIVIDUAL PRODUCTS DO NOT STICK TO ONE ANOTHER.
