

PINCO ADVISORY COMMITTEE MEETING JUNE 16, 2016 10:00AM PINCO SERVICE CENTER 3019 16TH STREET BAKERSFIELD, 93301

MINUTES:

1. SIGN-IN: 10:20 A.M. 22 Members Present

2. APPROVAL: ADOPTION OF AGENDA.

Recommendation: It is recommended Advisory Committee adopt the June 16, 2016 Advisory Committee Meeting Agenda as presented.

5. APPROVAL: ADDITIONAL ITEMS 2016-2017 PINCO BUYING GUIDE

Background:

Don Lee Farms- Based on additional Student taste testing with favorable ratings the following items are being proposed in consideration for inclusion in the 2016-2017 PINCO Buying Guide.

CNQ 62103 Reduced Sodium Whole Grain Breaded 100% Beef Fingers (4 pcs. = 1 serving) \$29.64/case QSC 328P Whole Grain Sunrise Sausage & Cheese Breakfast Sandwich, IW \$66.76/case

These items would draw down from diverted pounds per the EPDS provided. More items available for processing through awarded vendors provides increases options for greater use of entitlement as well as added variety in menu planning for Member Districts.

Recommendation: Lead Agency recommends the Advisory Committee accept the inclusion of the above items from Don Lee Farms into the 2016-2017 PINCO Buying Guide.

6. APPROVAL: PARLIAMENTARY TRAINING

Background: As placed on the Agenda and discussed at Executive and Advisory meetings this year, the Lead Agency and Member Districts have expressed interest in conducting a training session covering the Brown Act of 1953, Robert's Rule of Order and Parliamentary procedures. PINCO Members had recently attended the California School Nutrition Association's Leadership Training where the topic was presented. Those who attended this session thought Lorenzo Cuesta PRP, Professional Registered Parliamentarian was an ideal candidate for presenting this topic(s) to PINCO's Advisory Committee.

The Lead Agency has contacted Mr. Cuesta and requested a quote to provide a one-day training in the areas mentioned. Mr. Cuesta would charge \$300.00 plus one night's lodging for this training. If approved, the Lead Agency would schedule training on a date/location provided by the Advisory Committee.

Recommendation: It is recommended the Advisory Committee authorize the Lead Agency to schedule Lorenzo Cuesta PRP in training of Brown Act, Robert's Rules of Order and Parliamentary procedure for PINCO Member Districts.
